E-MAIL ADDRESSES AND **BIOGRAPHIES NEEDED** FOR ASP'S NEW WEBPAGE by Jack Armold

At the April 13 meeting, Susan Baker, SNU's Director of Academic Computing, requested that Academy of Senior Professionals (ASP) members forward their e-mail addresses to her for inclusion in the new SNU/ASP webpage: Baker's contact numbers are as follows:

Baker began teaching members of Research Interest Group (RIG) how to develop a webpage in the spring of 1997. The webpage is a dynamic document for it will be constantly changing throughout the years as it is updated with new information; the webpage will connect the ASP with the world-wide Internet.

It was explained that the way an Internet e-mail address looks is the same for everyone on the Internet. look againat Baker's e-mail address: < sbaker@snu.edu >. Did vou notice the @ symbol in the middle of the address? This symbol separates the address into two halves: the user name on the left and the domain name on the right.

The Internet does not care much about the user name. It pretty much sticks with delivering the e-mail to the computer named on the right side of the address. Then the computer delivers the e-mail to the mailbox identified on the left side of the address e.g. sbaker.

The domain name is the unique name given to a specific computer on the Internet. A domain has several words stuck together by periods. The right-most word is the top-level domain and usually defines the type of institution e.g. .edu designates an educational institution, and snu for Southern Nazarene University.

At this same meeting, a short biographical form was distributed to all present with a request that each ASP member complete one and return to Baker for inclusion in the biographical section of the webpage. Members can mail their forms to her at SNU Academic Computing or bring them to the next ASP meeting, May 9.

All ASP members are invited to attend RIG meetings where more hands-on demonstrations on the use of the Internet will take place in the 1998-99 academic year.

HEALTH CARE: 1.

Food supplements, Anti-oxidants, Nutrition, and Exercise/fitness.

> 3. **RECREATIONAL/TRAVEL:**

Elderhostels, Tours and Cruises. Slightly lower in priority but indicative of strong interest, were the two following areas: 1. Legal matters, including Wills, Trusts, Estate planning, Power of Attorney,

etc. Social security and its future. 2.

Members of the RIG Committee are appreciative of those who participated in the survey, and they will be conducting research on the selected topics. The results will then be conveyed to the membership of ASP.

#### **UNDERSTANDING THE WHOLE PERSON** by Lyle Flinner

Man has been trying to understand himself for a long time! Over thousands of years he has tried to focus on the areas which seem to be the most productive for selfunderstanding.

At times, this has led to decimating man, of breaking him up into small, unrelated parts which were studied in detail. But now, most disciplines accept man's wholeness as a given fact. It is clearly recognized that "the whole is greater than the sum of its parts."

Every one of us operates as a "whole" person. What does that really mean? One thing it means is that our present attitudes, actions, motivations, and goals are truly understandable only in relation to the "total package." This "total package" consists of all of our past experiences, all of the influences of other people upon our lives (both in the past and in the present), all of the pressures on our lives in every area, all of our circumstances, and all of our total physical condition. Each one of us acts and thinks as a person who is the final product of all of these influences.

So what is the implication for mature Christian living? One implication is very personal. When you view yourself as a whole, you are able to understand more thoroughly your actions and attitudes and drives. Such selfunderstanding is very basic to real spiritual maturity. As any psychologist knows, really understanding your problem is a long way on the road towards solving it.

The second implication of this concept that persons act out of their total background (both past and present) is related to our mature attitude toward others. We will be much more charitable (and Christian) in our dealings with others if we really try to see behind the word or action and attempt to understand them in the light of all of the pressures and influences (physical, emotional, financial, social, etc.) which are affecting the person.

When our perception of ourselves and others comes closer to the total reality of the situation, when we take into account all of the factors involved, we tend to increase and extend our mercy, becoming more like the Lord who extends such gracious mercy to us.
