The Academy of Senior Professionals' history, so nobly advanced through March 1998 by Dr. Paul Gresham, now rests in less skillful hands due to the request of Dr. Elbert Overholt and Dr. Jack David Armold that I, Lecil Brown, take up this task.

The Academy's Annual Meeting was held on April 13, 1998. Treasurer Bud Cargill reported a balance on hand of \$1,492,08 as of March 31, 1998. President Vada Lee Barkley indicated that it was time for her to take a little slower pace. She gave her eighth and final report, which was received with much appreciation. The nominating committee, Elbert Overholt, Chairman, and members June Phillips and Helen Silvey, presented a ballot, and the following officers were selected for the coming year:

A plaque was presented to Prof. Susan Baker, SNU's Director of Academic Computing, for her "dedicated service to the Research Interest Group and the Academy of Senior Professionals, 1997-1998."

On **May 11**, the final meeting of the 1997-1998 year, tribute was paid to Mrs. Vada Lee Barkley for her outstanding service to the **Academy**. She was presented with a check for \$500 and a clock/plaque inscribed with words of tribute. She replied with words of appreciation. Dr. Jack Armold, incoming president, presented a ceremonial gavel to Mrs. Barkley. SNU President, Dr. Loren Gresham, was special guest and speaker for the meeting. As always, he gave an upbeat report on what is happening on the SNU campus. He reported that work was progressing on the Sawyer Center and expected completion was by the second week of November.

The first meeting of the **Academy** for the 1998-1999 year was on **September 21.** Dr. Lloyd Glenn McArthur, highly respected physician and distinguished SNU Alumnus, was the special speaker. Dr. McArthur spoke on a subject of concern to many of the group's members, "Living with Arthritis." Progress toward developing the Academy Web Page was reported by Susan Baker and Chichi Freelander in the September *Perspective*. Also, Dr. Jack David Armold, new **Academy** president, wrote a thoughtful editorial which he titled "An Anatomy of the Academy."

The **October 12** meeting featured a speaker widely known as a scholar, evangelist, camp meeting speaker—Oklahoma's own Dr. Mendell Taylor. Dr. Taylor's wisdom, his friendship, and vast storehouse of knowledge always leaves his audience challenged to strive for excellence. The **ASP** Ad Council authorized the purchase of a paving stone to be placed on the SNU Centennial Plaza. The stone will read "Southern Nazarene University Academy of Senior

Professionals Founded 1990." Foreign travels by **ASP** members Milton and Mabel Sonnevik and R.T. and Pat Bolerjack delighted readers in the October *Perspective*.

Attorney James Posey was the speaker for the **November 9** monthly luncheon. Jim, a SNU alumnus, received his Juris Doctorate from the University of Oklahoma. He is a member of the Oklahoma and American Bar Association. His law practice has been in Bethany. Jim and wife, Shirley, are members and actively involved in Bethany First Church of the Nazarene. Jim's topic for the occasion was "Legal Matters Involving the Senior Adult." SNU President and Mrs. Loren Gresham held a reception for **Academy** members at their home following the meeting.

The final meeting during the calendar year 1998 was held on Monday, **December 14.** The incomparable Mark Reighard presented a musical program for the delight of all who were fortunate enough to be there. Dr. Reighard holds a Bachelor of Music degree from SNU, and a Master and Doctorate degree from the University of Oklahoma. He has been on the SNU faculty as a professor since 1969. He has served as pianist and organist for several churches in the Oklahoma City area. He has performed for banquets, retreats and other events hundreds of times and never failed to delight his audience.

Following the festivities of the 1998 Christmas Season, the new year got underway with a meeting on January 14, 1999. Before leaving 1998, however, this writer wants to note that three highly esteemed colleagues left us late in the year. Dr. Wesley Moon died on December 19. He received his Bachelor of Arts degree in science from Houghton College in 1933. He received his Master of Education from the University of Rochester and his Doctorate of Education from the State University of New York at Buffalo. Dr. Moon served as head of the Education Department of SNU for 25 years. Services were held Tuesday, December 22, 1998, at Bethany First Church of the Nazarene. Rev. Clifton Norell died on December 17 at the age of 85. He received a Bachelor or Arts degree in theology at Bresee College. Rev. Norell pastored churches in Kansas, Illinois, and Oklahoma during 40 years of full-time ministry. Doris Darlene Beaver Schumann died at her home in Bethany on November 19, 1998. Doris was a graduate of SNU. She served as a pastor's wife, and taught in the public schools and at SNU. The Academy welcomed nine new members at the January meeting: Hugh Bright, Frank Ellis, Mary Ann Ellis, Grant Keeton, Evelyn Keeton, George Miller, Mary Evelyn Miller, Ralph West, and Louise West. Bob Emmel introduced Marilyn Olson, well-known local Christian business woman, as the speaker. The title of her speech was "Hope and Options for Seniors."

The **February 1999** meeting focused on total well-being through exercise, diet, and emotional balance. It was noted that seniors are increasingly interested about these concerns. Bea Flinner, Chairperson of the Research Interest Group (RIG), was leader of the panel for the program. Bea, known as a very capable person, has a B.A. degree and three masters degrees. Dr. Wanda Rhodes has been a health educator and has served as SNU's Dean of Women and Chair of the Health, Physical Education and Recreation Department. "Nutrition and Exercise for Optimal Health" was her topic. President Armold spoke of his admiration for Dr. Kenneth Cooper's extensive research and his book <u>Antioxidant Revolution</u>. I note with sadness the passing of two distinguished educators, Dr. Merle Jamison on December 30, 1998 and Dr. Mendell Lee Taylor on January 23, 1999.

One significant part of the **March** meeting was the presentation of proposed changes in the Bylaws. Chairman Robert Griffin and the Bylaws committee had done extensive work to change and update the Bylaws. The revision was presented by Dr. Griffin who made a motion that the revision be adopted. The motion was seconded by member Charles Harrison, and it passed unanimously by the membership. New members Ruth Craddock, Rev. Dallas McKellips, and Rev. Art and Dorothy Evans were introduced. Dr. Forrest and Jean Ladd presented an informative and interesting program entitled "Principles of Genealogical Research." Forrest and Jean are honor graduates of SNU. Jean taught business courses in high schools and college and managed the Bethany Book Store for 39 years. Forrest earned the Ph.D. degree from the University of Kansas, and he devoted forty years to teaching and administrative work at SNU. After their retirement, Forrest and Jean did extensive travels in genealogical pursuits.

The annual meeting on **April 12** included reports, an election for new officers, and Steve Stearman's speech, "Southern Nazarene University's Adult Education." President Jack Armold gave his first annual report which he called "An Attitude of Gratitude." The ballot for the coming year was presented by Elbert Overholt, Director and Chair of the Nominating Committee. The following were elected:

The **May 10** meeting, the last one before the summer break, featured Dr. Roy L. Dorris who brought to our attention the problem of adverse drug interactions with so many new drugs on the market now available to the elderly. He stressed the importance of letting the doctor know what drugs have been prescribed if we see more than one doctor. Marguerite E. Ross, Assistant Principal at Putnam City Central Middle School, presented "The Song in my Heart." Prior to joining the Putnam City School System, Ms. Ross was director of vocal music and keyboard instructor for the public schools of Oklahoma City for fourteen years. The revised ASP Bylaws, approved in the March meeting, provided for a Strategic Planning Committee. Marilyn R. Olson was appointed the first Chairperson of this committee. Barbi Moore of Heart to Heart International gave a report of the organization's help for victims of recent tornadoes in our state.

The **October 11** meeting dealt extensively, through the Research Interest Group (RIG), with the research and publications of Dr. Kenneth Cooper. He published the book <u>Aerobics</u> in 1968. He showed the importance of exercise and later made nutritional therapy a key to seniors' wellbeing. Dr. Jack Armold, friend of Dr. Cooper, brought an excellent and detailed report on Dr. Cooper's contributions in the whole area of seniors' health. Dr. Elbert Overholt, director and founder of the **Academy of Senior Professionals**, was unable to attend the meeting due to heart by-pass surgery on September 27. Reports were that he was making good progress toward recovery. Mr. John Gillespie, President and CEO of Access Financial Group, Inc. in Bethany, was the special speaker on **November 8.** He has fifteen years of experience in the field of estate planning. After his able presentation he gave opportunity for **ASP** members to ask questions.

With the spirit of Christmas in the air, the **December 13, 1999**, meeting brought the Chamber Chorale of the School of Music at SNU to perform for us. The group was directed by Professor David Miller. Following the Chorale's performance, Prof. Miller led the entire group in singing Christmas carols. The **Academy** welcomed Dr. Elmer and Marjorie Shellenberger as new members. President Jack Armold wished all "good health and peace of mind" for the coming year. For the December issue of the *Perspective*, Dr. Annabelle Laughbaum wrote a very meaningful poem entitled "Thoughts for December."

#### ASP Moves into its Second Decade and a New Millennium

As we approached **January 1, 2000**, there was much in the news and print media about the possibility that computers would crash, and that widespread chaos would result. In fact, the transition to a new millennium went smoothly, and life moved on. The Academy welcomed Dr. Rex Tullis as speaker on **January 10.** Dr. Tullis has been Chair of the School of Education at Southern Nazarene University since 1995. He is very knowledgeable in the areas of education and computer technology. He encouraged seniors to adapt to the computer and all the other electronic gadgets we must deal with, although reluctantly at times. After the luncheon, Academy members were invited to visit Southern Plaza for dessert and a special tour. Southern Plaza is a retirement facility owned by SNU. New members Bobbie Steele, Pat Burton, and Richard and Carol Spencer were introduced to the meeting. Dr. Robert Emmel reported that he and Naomi recently completed a delightful cruise to the Empires of the Black Sea.

Four new members were welcomed on **February 14** bringing the total membership to over 160. New members were Park and Wynona Burkhart and James and Violet Weeks. An outstanding program of music was presented by Rosa McCroskey, Myra Schubert, Evelyn Keeton and Pat Bolerjack. Bea Flinner's RIG group had been working on a topic of interest to everyone – genealogy. She introduced Glorene Brown who has devoted many years to the search for ancestors. There was so much interest in the subject that another meeting was scheduled so there would be time for additional information to be presented. In February, the By-laws committee, chaired by Bob Griffin, met to consider changes in the **Academy** By-laws recommended by the Committee on Publications. The proposed changes were to be presented at the April meeting.

Distinguished public servant George Miller was speaker for the **March 13** meeting. Miller served ten years in the Oklahoma State Senate. He, along with his wife, Mary Evelyn, three sons and a daughter, moved to Bethany, from Ada, OK. The March meeting was held in the Chapel-in-the-Round of Bethany First Church of the Nazarene.

Several items of business were on the agenda for the **Aril 10** meeting. President Jack Armold gave his annual report. He reviewed several achievements of the **Academy** during the 1999-2000 academic year. Dr. Robert Griffin, chair of the By-laws committee, presented a motion to establish a Committee on Publications as the fifth standing committee, and the motion was approved. Rev. George Cargill, Treasurer, presented a recommendation of the Administrative

Council that annual membership dues be increased from \$10 to \$12. The recommendation was approved. Dr. Elbert Overholt, Director, presented a resolution calling for the establishment of an ASP Scholarship Endowment Fund in the amount of \$10,000. This, as well as other proposals, received unanimous approval. Rev. George Cargill gave the Annual Treasurer's report for the fiscal year which ended March 31. Dr. Armold noted that membership in the Academy is now167—an "historical record." President Jack Armold and Secretary Darlene Overholt were re-elected by acclamation.

The last meeting until monthly meetings resume in October, was on **May 8**. Dr. Dudley Powers was the special speaker. Dr. Powers has given most of his life in service to the Church of the Nazarene. As reported in the *Perspective*, he received his M.D. degree in 1962 from the University of Texas Medical Branch, Galveston, Texas. After two years of medical practice in Bethany, OK, he accepted an assignment as a physician and administrator in New Guinea for four years. He then returned to Bethany where he was associated with the Bethany Medical Clinic until his retirement in early 2000. Dr. Powers is a much respected Bethel Bible teacher and Sunday School teacher. His topic was "Science and Religion, Conflicts and Consequences."

SNU president, Dr. Loren Gresham, welcomed the ASP members for the beginning of the 2000-2001 academic year on Monday, October 9, 2000. Dr. Gresham has been with SNU since 1967 when he started as professor of political science. He was born in Nashville, TN where he attended Trevecca Elementary Training School. When his parents moved to Pasadena Nazarene College, he went to Pasadena Academy and then to Pasadena Nazarene College where he graduated with an B. A. in history. He received his M.A. from the University of Southern California in international relations and later his Ph.D. in political science from the University of Oklahoma. He was selected to be provost of SNU in 1985, and the SNU Board of Trustees elected him president in 1989. Dr. Gresham married Linda Lee Brown in 1964. They have one daughter and two grandsons. President and Mrs. Gresham welcomed the ASP members to their home for an open house and reception following the meeting. ASP president Dr. Jack David Armold, in his monthly reflections in the *Perspective*, reminded his readers of this bit of advice from George Burns: "if you want to live to be 100 or older, you can't just sit around waiting for it to happen, you have to get up each day and go after it." Dr. Robert Emmel's thoughtful comments on a "Design for Christian Living" pointed out that the ideal system of ethics was to be found in the Sermon on the Mount.

The November 13 meeting provided the privilege of hearing attorney and *Daily Oklahoman* columnist Jim Priest. His weekly column "Family Talk" has many appreciative readers. He has also published a book with the same title. The title of his presentation was "The Continuing Challenge to the Greatest Generation." Jim and his wife, Diane, and children, Amanda and Spence, are members of the Oklahoma City First Church of the Nazarene. SNU professor Sue Anne Lively reported some of the findings her research observed about the habits and activities of seniors as she continues work on her dissertation. Her findings were complimentary to us. New members Robert and Beverly Parker, and Jarrell and Bernice Garsee were welcomed to the meeting. Dr. Anna Belle Laughbaum wrote a thoughtful and insightful poem for the *Perspective* titled "Lessons from the Leaves."

Dr. Barnard has recently retired from Eastern Nazarene University. Marilyn Bergman, SNU Alumni Director, talked to the group about alumni activities.

Guest speaker on **January 8, 2001** was Bethany City Manager Dan Gallaway, Mayor J.D. Johnston was scheduled but was unable to appear and asked the city manager to report instead. Gallaway gave an up-to-date report on matters concerning the citizens of Bethany. SNU professor Sue Anne Lively brought an update on her extensive research into the lives, interests, commitments, plans and programs of the ASP members, all of which she is using for her doctoral dissertation. This writer has read most of her work and it is truly impressive. For the *Perspective*, Dr. Robert Emmel wrote the second part of the world travels he and Naomi enjoyed last year. His report covered their visit to Moscow, Red Square and other scenes from the socialist revolution. Their tour came to an end after a visit to Helsinki, Finland and London. Bea Flinner, chair of the RIG group, feature writer Vada Lee Barkley and book review editor Winni Howard continued to make important contributions to the *Perspective* in the areas of their interest.

The **February 12** meeting brought to us Lt. Colonel (retired) Charles A. "Chuck" Garrison. He was recently appointed State Coordinator for the Oklahoma Centennial Commission. He and his staff will provide leadership for the numerous projects leading up to 2007. Lt. Col. Garrison is a native of Bartlesville, OK. He served as an infantry officer for nearly 25 years. His assignments took him to Ft. Benning, GA, Hawaii, at the Joint Readiness Training Center in AR and at the U.S. Headquarters Forces in Japan. He and his wife, Laurie, also from Bartlesville, now reside in Edmond with their three sons, Reid, Cole and Doss. His subject was "Oklahoma's Centennial 2007." New members Garland and Edith Johnson were welcomed. Glendena and Gene Adams reported on obituaries of three much loved members who died recently and will be greatly missed. Rev. George O. "Bud" Cargill died on December 14, 2000. Ruby Takemire died on November 16, 2000, and Dr. Olan Moore died on December 23, 2000 at the age of 96.

Milton Sonnevik introduced guest speaker Paul Dougherty for the **March 5** meeting. Prior to the speaker's introduction, Milton reviewed the history of Oklahoma City's Deaconess Hospital, which Mr. Dougherty now serves as president and chief financial officer. Deaconess has served the health needs of this area for over 100 years. It was given the name Deaconess Hospital because everyone referred to it as "the hospital that the deaconess ladies ran." Bea Flinner arranged for Glorene Brown to present another genealogy workshop following the luncheon. Pat Beck, Jonathan Gassett and Helen Jamison were welcomed as new members.

The Academy was fortunate to have Drs. Les and Leslie Parrott as speakers on April 9. The Parrots, at the request of Governor Frank Keating, spent a year in Oklahoma traveling throughout the state speaking in churches, service clubs, schools and to state officials. The purpose was to try to lower Oklahoma's high divorce rate. The speakers are authors of many articles published in national magazines and have been guests on CNN and TV programs including "Oprah," "NBC Nightly News," "CBS This Morning." They took this time from their regular duties as faculty members at Seattle Pacific University. Dr. Paul Gray, director and prime mover for SNU's archives, reported that over 4,000 items have been collected, organized, catalogued, preserved in acid-free containers, and available for research. These important items have to do with the founding of Southern Nazarene University and the City of Bethany. This has been a labor of love for Dr. Gray over the last 18 years. The archives are presently located on the third floor of the R.T. Williams Learning Resources Center. Dr. Gray earnestly hopes for a permanent home in the visitor's center building to be built on the SNU campus in the future. Book reviewer Wini Howard's feature in the ASP Perspective gave an interesting review of Gen. Colin Powell's autobiography, My American Journey. Powell's account is of his journey from the time when a Southern city would not allow him to eat in the restaurant, to a time many years later when it gave him a hero's welcome. This account indicated to him that progress was being made in race relations in our country.

"Our Own" Sue Anne Lively was the speaker for the May 7 meeting. The title of her presentation was the same as the title of her Ph.D. dissertation, "Learning, Growing, and Aging. Life-long Learners in the Academy of Senior Professionals in Bethany, OK." Sue Anne seems like one of us because of her parents, Bud and Trudie Cargill. Being an SNU graduate and now professor, she currently teaches in the School of Adult Education and is director of the Alternative and Prior Learning Program. As reported earlier, she has done extensive research into the lives, careers, and contributions of many ASP members to academic, church and community endeavors. Sue Anne is married to Dr. Robert Lively, head of the History and Political Science Department at Southern Nazarene University. They have one son, Patrick. President Jack Armold had invited the SNU department chairs as his guests and those able to attend were: Dr. Ann Ferguson, Dr. Hal Cauthron, Dr. Pam Broyles, Dr. Robert Lively, Dr. Martha Banz, and Dr. Larry Mills. A string quartet from the SNU School of Music entertained us during the luncheon. The students were: Bryan Young, Hazel Snowbarger, Leslie Cannata and Sarah Michel. Marge Fisher and Sherryl Gassett Gordon were welcomed as visitors. In this month's issue of the *Perspective*, Vada Lee Barkley gave a moving tribute to her husband, Rev. Arthur Barkley, under the heading "My Sweetheart's Homegoing." Rev. Barkley-"Art" as he was affectionately known-died in Oklahoma City on March 16, 2001. He was born in Ohio on June 30, 1916. He was converted at a young age, joined the Church of the Nazarene at the age of 9 and devoted his life in service to God and his church. Art and Vada Lee met in Yukon, OK in 1950, were married, and worked together as a team.

The fall sessions got under way **October 8** with special speaker Dr. James Poteet. "Jim," as we all know him, and his wife, Peggy, have been members of the faculty of Southern Nazarene University for many years. Jim served as Associate Professor of Physical Education, basketball coach and Athletic Director from 1971-1979. Since his retirement he has been very active in the community's after-school educational program at the Floyd Center. Dr. Peggy Poteet is

chairperson of the Division of Humanities at SNU. They have one son, Josh. Dr. Poteet's presentation was well received by ASP members. It was announced in the *Perspective* that Dr. Anna Belle Laughbaum's autobiography, <u>Nine Glimpses of My Life</u>, had just been released.

Southern Nazarene University President Dr. Loren Gresham brought the Academy membership up-to-date on the university's operations and programs on November 12. Dr. Gresham has a distinguished record in Nazarene higher education. His service at SNU began in 1967 as a professor of political science and history. In 1985 he was selected by then President Ponder Gilliland to serve as Provost of SNU. The Board of Trustees elected him President of the University in 1989, the office he still holds. Dr. Gresham and his wife, Linda Brown Gresham have one daughter, Suzanne Lynnette Strawn. She and her husband, Dr. Brad Strawn, have two sons, Evan Bradley and Keaton Paul. Dr. and Mrs. Gresham entertained Academy members in their home following the noon luncheon.

The **December 10** program, following a practice of previous years, featured a musical program. SNU's handbell choir, under the direction of Professor Brad McKenzie, provided the special music. Prof. McKenzie received his B.S. degree in church music and a B.S. in religion from Southern Nazarene University in May, 2000. Prior to joining the SNU music faculty in August, 2001, he served the Community Church of the Nazarene in Midwest City and the Oklahoma City First Church of the Nazarene. He is also an Associate Pastor and Minister of Music of the Lake View Church of the Nazarene.

Before beginning 2002 on January 10, we note with sadness the loss of three faithful and longtime members in December, 2001. Gene Adams died on Sunday, December 9. Gene was born in Knowles, OK on April 13, 1928. He moved to Bethany in 1945. He was a long-time member of Bethany First Church of the Nazarene and a community leader. Gene is survived by his wife, Dena, and three daughters. Colleen Karns Cornwell died on Thursday, December 13. Colleen was born February 21, 1926. She grew up in Ford, KS and graduated from high school there. She is survived by her husband, Don, and a sister, Jean Ladd. Shural Knippers died on Tuesday, December 11. Shural was born August 6, 1923. He was a graduate of Bethany Peniel College, and did further graduate work at Baptist Seminary in Ft. Worth, TX and UCO in Edmond, OK. Shural had a distinguished career as a chaplain in the U.S. Air Force, retiring as a Lt. Col. He is survived by his wife, Carolyn, two sons and a daughter. Speaker for the January meeting was Mr. Russ Urguhart. He is the new director for Cornerstone. On April 19, 2001, Cornerstone was awarded the contract from the Department of Human Services to act as an intermediary organization to work with 2,771 faith communities in forty-seven Western Oklahoma counties. Cornerstone's goal is to work with the various social service agencies to provide services to the poor and needy. Bobbie Steele was recently appointed chairperson of the ASP membership committee. Preliminary planning was started for the 2002 Senior Adult Conference to be held April 18.

It was a real pleasure to welcome Dr. Tom Barnard to the meeting on **February 11**.
