**ASP** members returned for the 2006-2007 academic year on **October 2, 2006**. Dr. Pat Allen, SNU Provost, was the special speaker. Dr. Allen came to the university as provost in August 2006. His extensive educational background and experience at other institutions lets him speak with valuable insight into academic matters, which he does with wit and humor. He holds the Ph.D. in Higher Education from the University of Oklahoma. The title of his speech was "The Provost's Vision for SNU." Dr. Loren Gresham, SNU President, announced the appointment of Brenda Styers as co-director of the Academy of Senior Professionals. She will serve with Dr. Elbert Overholt during this academic year and assume full responsibility as director in 2007. Billie Harrison reported the death of Vivian Chambers, a faithful and active member of the **ASP**. Vivian Chambers, 82, died on August 9, 2006. She graduated from Bethany Peniel College in 1950. She is survived by her husband, Gene, their daughter, Theresa West of Kirksville, MO and son, Paul Chambers of Flanders, NJ. She is also survived by two brothers, Lee Hillery and Paul Hillery, and one sister, Wilma Norsworthy.

Dr. Tom Barnard was the featured speaker on **November 13.** Dr. Barnard, highly respected educator and administrator, chose as his speech topic "Creating a Legacy—Without Giving Away the Store." He retired in 2001 from Eastern Nazarene University where he served as Vice-President for Institutional Advancement. He and his wife, Madelyn, moved to Oklahoma City after retiring from Eastern Nazarene University in Quincy, Massachusetts. During his presentation he introduced Michael Crabtree, Assistant to the President of Southern Nazarene University, who spoke on establishing scholarships at SNU. In the Administrative Council meeting following lunch, Naumi Emmel reported that her husband, Robert Emmel, will no longer be able to serve as Chair of the By-laws Committee due to his failing health. New membership directories for 2006-2007 were made available by Dr. Don Beaver, Chairman of the Publications Committee. Amedisys Home Health Care provided the luncheon subsidy.

The Academy of Senior Professionals looks forward each year to welcoming Dr. Loren Gresham as speaker for the December meeting. She is survived by three children; Linda Brown Gresham, Oklahoma City, Warren S. Brown, Pasadena CA, and Frederick Lyle Brown, Santa Barbara, CA. Wayne Cordell Bright, 89, died on January 18, 2007. Wayne grew up in Ardmore, OK. He was a veteran of WWII, having served in the U.S. Army Air Corp. After his WWII service, he went to Baylor School of Dentistry. He was active in dental practice in Tulsa, OK, later in Owasso, OK and in McAlester, OK. After the passing of his first wife, Thelma Jean, he moved to Bethany, OK and married Carolyn Barnes. George Williams, 79, died on March 13, 2007. George was known for his commitment to foreign missions. He served as missionary president at Del City First Church of the Nazarene for many years. In WWII he proudly served his country in the US Merchant Marines and the USAF. He was preceded in death by his first wife, Catherine, son John, and brother, Cecil. He is survived by his wife, Betty, sons, Ken Williams, Ron and Dennis Watson; his daughters Fran Ward, Susan Downs, and Shelly Spearman; and his brother Crawford. These three outstanding persons were members of the Academy of Senior Professionals. The luncheon subsidy was provided by Compton Orthopedic Service.

For the last meeting of the academic year, and for anticipation of the coming summer months, Dr. Juanita Krittenbrink, on May 14, gave a speech fitting for the occasion: "Rising Above the Crowd." The speaker was Rear Admiral (retired) Gregory Slavonic. Admiral Slavonic is coo-chair of the USS Oklahoma Memorial Committee. The committee's purpose hs been to establish a proper memorial to the 429 men aboard the USS Oklahoma who lost their lives on that "day of infamy," December 7, 1941. The memorial is set for December 7, 2007. The Ad Council voted to make a contribution of \$100 to this project. Other items on the Council agenda were to approve the revised By-laws presented by Harold Dozier, and send them on to Dr. Loren Gresham. Roy Dorris gave the treasurer's report, which was approved as presented. An expression of thanks was given to Cathy Allen, Executive Director of VistaCare for the lunch subsidy this month.

The Academy welcomed Barbi Moore of *Heart to Heart International* as special speaker on **November 12**. Barbi has been with *Heart to Heart* since it began in 1992. She was the first part-time employee and advanced to her present position of Chief Advancement Officer. The organization, founded by Dr. Gary Morsch, is a humanitarian organization that has served thousands with necessary medicines and medical training. It has distributed over one-half billion dollars of donated humanitarian aid to the needy in many countries. Barbi is the wife of Bethany First Nazarene Minister of Music, Harlan Moore. It was noted that November 11 is officially recognized as Veterans Day in honor of all of America's veterans. The obituary of Sam Davis, A WWII Navy Veteran, was printed in the November *Perspective*. Sam died on October 15, 2007. He was born September 24, 1926 in Pachuta, MS. He is survived by his wife, Edna. Sam was a true churchman, a devoted husband, father and a friend to all who knew him. Member Ron Mercer and Mercer-Adams Funeral Service sponsored the luncheon today.

Dr. Gresham's meeting with the grou had to be postponed. Dr. Lyle Tullis, much loved retired SNU professor, died on October 30, 2007. He was 86. He was a WWII veteran. Before coming to SNU, he taught at Oklahoma Wesleyan University. While teaching there he earned the Ph.D. at Oklahoma State University. He was preceded in death by his wife, Dawn, and is survived by three sons, Rex, Ross and Kim.

The new year didn't get started exactly as planned. Ron Mercer, native Oklahoman, highly successful retired Xerox official, and one of our own **ASP** members was scheduled to speak on **January 14, 2008**. However, Ron did not get back from a trip to Viet Nam for the meeting. Undaunted program chair Shirley Mears was able to get Dr. Andrea Mears for the January speaker. Dr. Andrea Mears holds a Doctor of Audiology degree from the University of Oklahoma Health Sciences Center. As a member of the *Hearts for Hearing* team, Dr. Mears specializes in pediatric and adult diagnostic audiologic services, adult amplification and adult cochlear implants. Dr. Paul Scheie, new chair of the Research Interest Group, chaired his first meeting of that group. Long-time **ASP** member Fred Morgan, Jr. died on November 27, 2007. He was active in home building and marketing. He was a cherished friend who

Later, after retiring from teaching at Redlands Community College, she wrote poems, songs, articles and books for publication. She was involved in the organization of the Academy of Senior Professionals and served as its first president until 1998. She was preceded in death by her husband, Rev. Arthur Barkley. Program chair Shirley Mears arranged for the president and owner of the Gospel Station Network. Randall Christy, to speak to the ASP on April 14. Randall's mission has been to spread the Gospel through radio broadcasting. Graduating in a small high school class of 14 in Schulter, OK, he studied at East Central University, where he met his wife, Susie, and later received his Masters Degree in Education. Randall, along with a team of family and friends, have built a network of seven radio stations that covers most of Oklahoma and extends into Texas.
